Grammy Award Winner, Luis Fonsi, to Perform at the Patchogue!

He has presented at the Latin Grammy awards along with ZZ Top guitarist Billy Gibbons and has been invited to perform at the 16th annual Nobel Peace Prize concert December 11 in Oslo, Norway.
