Early in his career, he was an attorney with the Legal Aid Society, Criminal Defense Division, and still maintains a criminal practice that includes many high profile cases.

Ferro and the firm are also active in the community. In 2009 alone, the firm donated 250 flu vaccines to migrant day workers, distributed clothes and backpacks to children, and ran the annual Thanksgiving turkey drive and holiday toy collection. Ferro, Kuba, Mangano, Sklyar, P.C. has offices in Manhattan and Hauppauge, Long Island.
